Valley Campground Regulations

Food must be properly stored 24 hours per day. No food in vehicles. ALL food, ice chests, grocery bags and anything with a scent, such as soap, sunscreen, hairspray, toothpaste, candles, etc. must be stored in metal food storage lockers except when preparing meals. Treat your locker like a refrigerator—closed and latched when not in use. Hard-sided recreational vehicles may store food inside provided it is not visible from the outside and all doors and windows are closed when unattended.

Dispose of trash regularly in bear-proof dumpsters. Do not hang trash in your site.

Campfires are permitted year-round in established grates. However, from May 1 to September 30, wood fires are allowed only between 5PM to 10PM. Fires must be attended at all times and extinguished with water so that coals are cold and no smoke is visible.

No wood gathering in Yosemite Valley; this includes pine cones and needles.

No switching sites. Camping is permitted in designated, assigned sites only.

Generator use is permitted during the following periods: 7AM to 9AM, 12PM to 2PM, and 5PM to 7PM. Please use generators as little as possible during these times.

Quiet hours are 10PM to 6AM.

Check out time is noon on the day of your departure. Please depart on time and leave a clean camp.

Two motorized vehicles maximum per site. All vehicles, trailers and tow dollies must be parked on the established paved parking pad designated for each site. Additional overnight parking is available near Curry Village. Valid campground car passes must be displayed in all vehicles.

Connecting to any utility system is prohibited. Restroom electrical plugs are for restroom appliances only. The park is not responsible for lost or stolen items.

Wash dishes at your campsite. Dispose of dishwater in the utility sink between the restrooms.

Pets must be on a leash no longer than 6 feet. Pets may not be left unattended and tied to an object. All pet excrement must be removed and disposed of in dumpsters.

No digging, trenching, or leveling of the ground.

No driving nails, stakes, or other objects into the trees. Pad any rope, string, or cord around trees to protect the bark.

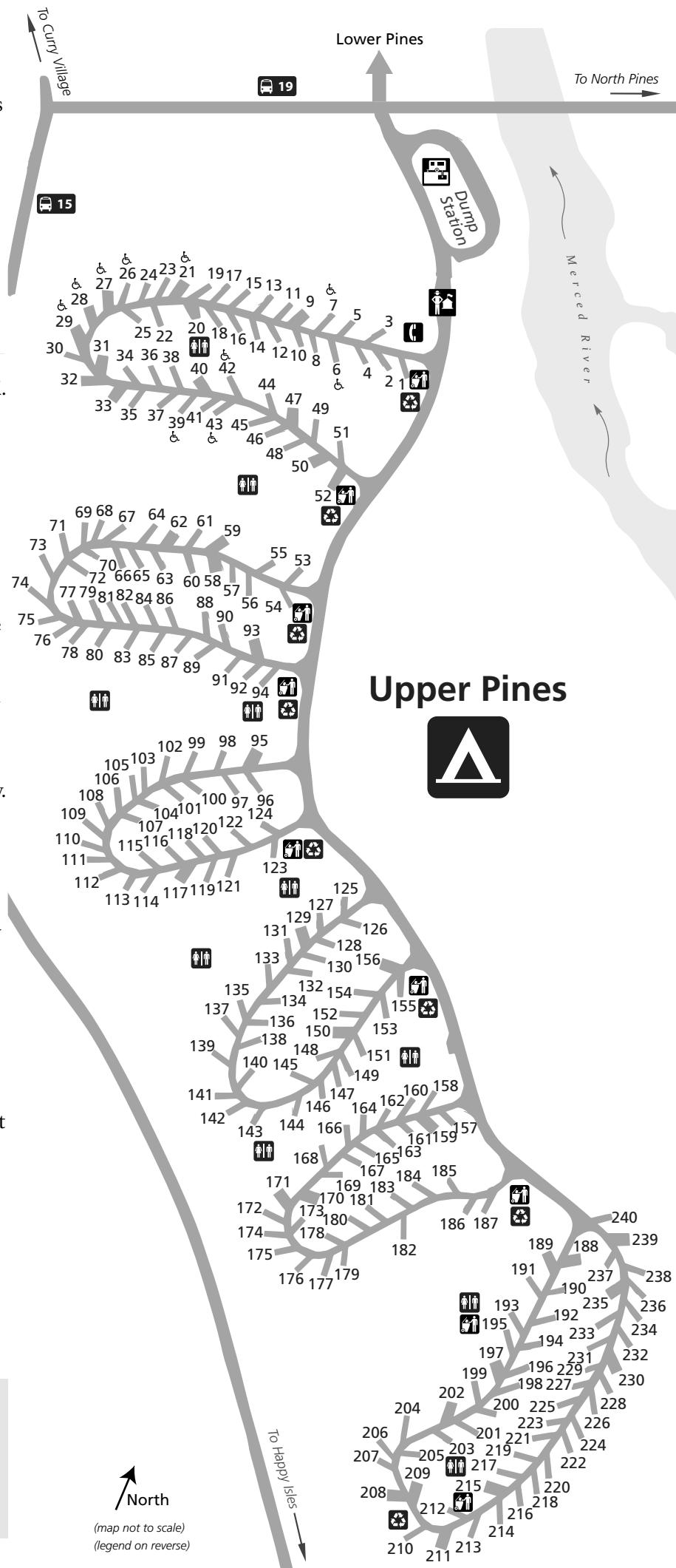
Six people maximum per site, including children.

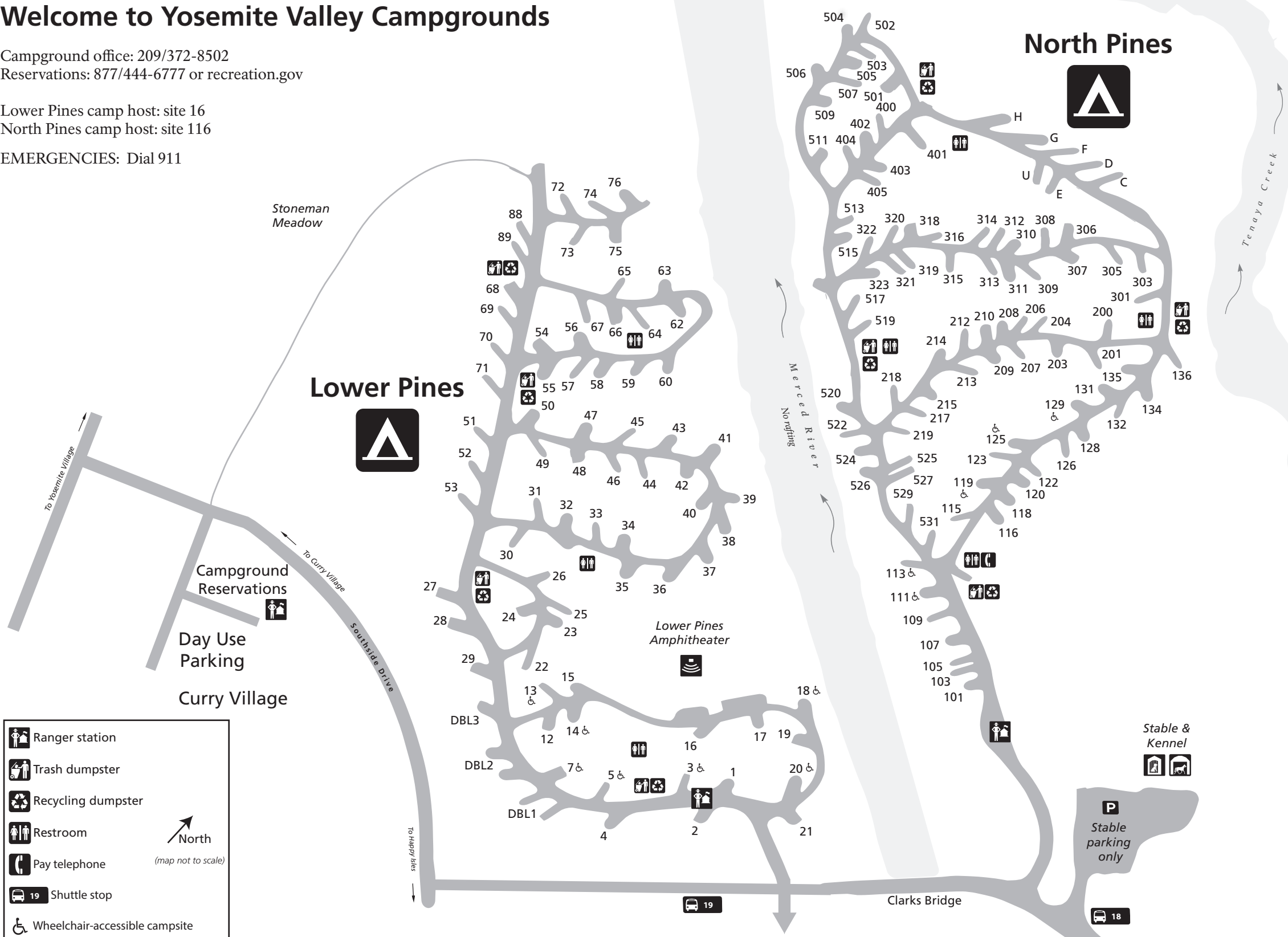
