

## Frequently Asked Questions Regarding Local Services and Attractions

### ***What is the status of Glacier National Park services?***

Glacier National Park is open with limited services. (Additional info is available at [explorewhitefish.com](https://www.explorewhitefish.com)) as of Oct 12, 2020:

- Access will be available at the west entrance (West Glacier) only. The east side park entrances are closed for the season.
- Currently, visitors can travel in vehicles from the West Glacier entrance station to Avalanche Creek. Weather permitting it could open back up to Logan pass, but this can change daily/hourly. (The Going to the Sun Road is scheduled to close at Avalanche Creek starting on Oct 19, 2020.)
- The Polebridge/North Fork entrance station is open as a day-use area and access to backcountry campsites
- Visitor information services at Apgar Visitor Center are open weekends only through the end of October, weather permitting. Restrooms and potable water are available at the Apgar Visitor Center plaza year-round.

### ***What about travel restrictions on tribal lands, specifically the east side of Glacier National Park?***

Visitors to Montana should be aware of travel restrictions related to the COVID-19 pandemic may vary on the seven Indian reservations in Montana. As tribal governments continue to assess public health risks, travel restrictions may change at any time depending on current conditions. In Glacier Country, visitors may drive through the Blackfeet Indian Reservation and the Flathead Indian Reservation; however, services may be limited or unavailable, and recreation areas on tribal lands have been closed to non-residents. Plan to save any on-reservation activity for a future visit. Additionally, the eastern entrances to Glacier National Park are closed.

### ***What happens if I test positive for COVID-19 while I am visiting the area?***

If an individual tests positive in Flathead County, they will be required to isolate until they meet CDC criteria for release from isolation. Release from isolation must be cleared by the Health Department (MCA 50-18-107). If the individual is unable to leave Flathead County, isolation may result in someone staying in their current lodging situation for a longer period of time than initially planned. Please contact your host immediately.

### ***Am I required to wear a mask in public while in Montana?***

Effective July 15, 2020, the use of face coverings is required within the State of Montana.

- Face coverings are **REQUIRED** to be worn in all indoor spaces open to the public.

- Face coverings are **REQUIRED** to be worn for outdoor activities where social distancing is not possible or is not observed.

Notable Exemptions:

1. Children under the age of five. Children between the ages of two and four are strongly encouraged to wear a face covering. Children under the age of two should not wear a face covering.
2. Persons consuming food or drinks in a restaurant or bar.
3. Persons engaged in an activity that makes wearing a face covering impractical or unsafe, such as strenuous physical exercise or swimming.
4. Persons seeking to communicate with someone who is hearing impaired.
5. Persons giving a speech or engaging in an artistic, cultural, musical, or theatrical performance for an audience.
6. Persons who have a medical condition precluding the safe wearing of a face covering.
