**RENTAL AGREEMENT:** I accept for use in its AS IS condition the equipment listed on this rental form and accept full responsibility for its care while it is in my possession. I will be responsible for the replacement, at full retail value, of any equipment rented from the Rangeley Lakes Cross Country Ski Club (RLXCSC) under this agreement, which is not returned. I agree to reimburse RLXCSC for any loss or damage of any kind to the rental equipment other than reasonable wear and tear. I agree to return all rental equipment on the agreed upon date, in clean condition, to avoid additional charges. I have made no misrepresentations to the RLXCSC in regard to my height, weight, age or skiing ability. All instructions on the use of my rental equipment were made clear to me and I understand the function of the equipment. I agree that the equipment will be used for the purpose of skiing at the Rangeley Lakes Trails Center only. I agree that there are no warranties, expressed or implied, which have been made to me concerning the ski equipment.

**RELEASE OF LIABILITY:** I accept and clearly understand that there are inherent and other risks, dangers and hazards associated in the sport of skiing for which this equipment is to be used which can result in serious personal injury or death and that injuries are a common and ordinary occurrence in this sport. I further recognize and acknowledge that the risks inherent in the sport of skiing can be greatly reduced by taking lessons, abiding by the Skier Responsibility Code, and using common sense. I understand that the boot/binding system which I have rented is not designed to reduce the risk of certain injuries to the lower leg. It will not release automatically, nor under any circumstances where a release may prevent an injury, and therefore does not guarantee my safety. I further agree and understand that the boot/binding system which I have rented does not have an automatic release capability, backwards, forwards, or sideways and therefore will not protect any part of my body in the event of a fall.

I, the undersigned, in consideration of the rental of the equipment by the RLXCSC, hereby release and fully discharge the RLXCSC, its owners, agents, and employees from any and all liability resulting from personal injury to myself or damage to my property which is caused in any way by the negligence of RLXCSC or any of its owners, agents, or employees in the installation, adjustment, inspection, maintenance and/or rental of the equipment, and/or the instructions given or not given to me concerning the equipment and its use, and/or from my use of this equipment. I accept full responsibility for any and all injuries or damages of any kind which may result from the use of the ski equipment and it is my intention to hold the RLXCSC, its owners, agents, and employees harmless for any injury sustained by me while using the above described ski equipment. In the event that I am signing as a parent of a minor, I represent I have full authority to do so, realizing this release is binding upon the minor as well as myself. I, the undersigned, acknowledge that I have carefully read this release of liability and rental agreement and understand its contents. I am aware that by signing this agreement, I am waiving certain legal rights, including the right to sue. *Caution: read before signing this document.
